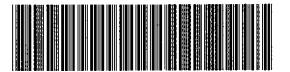

ARTICLES OF INCORPORATION OF KEVIN C. BEUTTENMULLER, P.A.

The undersigned incorporator, for the purpose of forming a professional service corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

ARTICLE I

- (3) The foregoing clauses shall be construed as both objects and powers; and it is expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner the powers of this Corporation.

ARTICLE VII

The Corporation's existence will commence on July 1, 2011.
