

**ARTICLES OF INCORPORATION
FOR PROFIT
STISKIN & COMPANY, INC**

ARTICLE I - NAME

The name of this corporation is STISKIN & COMPANY, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

The purposes for which this corporation is organized are as follows:

Section 1. To provide a legal entity to receive, hold, invest, and disburse funds, and to make and enter into contracts for services, products, obligations; and to buy, sell, lease, rent, mortgage, deal in, convey, or dispose of, real and personal property; and engage in such transactions as may be reasonably required to effectively promote, conduct, and administer the purposes of this corporation.


