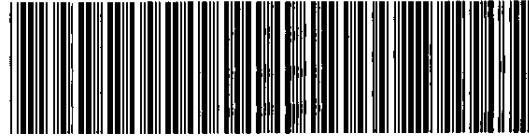

ARTICLE I


The Incorporator of said corporation, at a meeting called and held on July 1, 2011, adopted the following Resolution:

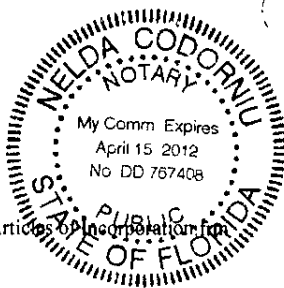


