ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF Q LIFESTYLE PROPERTIES, INC., a Florida corporation

Pursuant to Sections 607.1001, 607.1003 and 607.1006, Florida Statutes, Q LIFESTYLE PROPERTIES, INC., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Q LIFESTYLE PROPERTIES, INC.
