

ARTICLES OF INCORPORATION SECRETARY OF STATE
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights, privileges, immunities, and liabilities of incorporation for profit.

#### ARTICLE I

The name of the corporation should be:

#### ARTICLE II

The corporation will engage in any activity or business permitted under the laws of the State of Florida and the United States of America.

#### ARTICLE III

The maximum number of shares, which the corporation is authorized to issue and have outstanding at any one time, is 100 shares of common stock, one dollar (\$1,00) par value.

All stock is to be issued as fully paid and exempt from assessment.

#### ARTICLE IV
