ARTICLES OF INCORPORATION
OF
FINCH EQUIPMENT, INC.

ARTICLE I

Name. The name of the Corporation is "Finch Equipment, Inc." (the "Corporation").

ARTICLE II

Principal Office and Mailing Address. The street address of the principal office and the mailing address of the Corporation is 492 Timber Ridge Drive, Longwood, Florida 32779.

ARTICLE III

Business Purpose. This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

Capital Stock. The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having no par value.

ARTICLE V

Term of Existence. The Corporation shall have perpetual existence.

ARTICLE VI

The directors may authorize and require the payment of the reasonable expenses incurred by directors in attending meetings of the directors. Nothing in this Article shall be construed to preclude a director from serving the Corporation in any other capacity and receiving compensation therefor.
