ARTICLES OF INCORPORATION

OF

FINCH EQUIPMENT, INC.

ARTICLE I

Name. The name of the Corporation is "Finch Equipment, Inc." (the "Corporation").

ARTICLE II

<u>Principal Office and Mailing Address.</u> The street address of the principal office and the mailing address of the Corporation is 492 Timber Ridge Drive, Longwood, Florida 32779.

ARTICLE III

<u>Business Purpose.</u> This Corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV

<u>Capital Stock.</u> The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 10,000 shares of common stock having no par value.

ARTICLE V

Term of Existence. The Corporation shall have perpetual existence.

ARTICLE VI
