Pursuant to the provisions of Section 607.1006, Florida Statutes, SIMETRI ONE, INC., a Florida corporation (the "*Corporation*"), hereby adopts the following amendment(s) to its Articles of Incorporation:

1. The Corporation's present name is "SIMETRI One, INC."
2. The Articles of Incorporation of the Corporation were filed on July 12, 2011.
3. The text of each amendment adopted is as follows:
 - (a) ARTICLE I IS DELETED IN ITS ENTIRETY AND REPLACED WITH THE FOLLOWING NEW ARTICLE I:

"ARTICLE I
NAME

The name of the corporation is '*SIMETRI, Inc.*'"

4. These Articles of Amendment do not provide for an exchange, reclassification, or cancellation of issued shares.
5. The date each amendment reflected in these Articles of Amendment was adopted was August 26, 2011.
