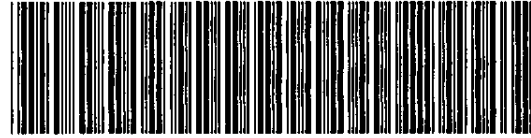

The undersigned natural person, acting hereby as Incorporator for the propose of forming a Corporation for profit under the provisions of Chapter 607, Florida Business Corporation Act, of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I
Name of Corporation

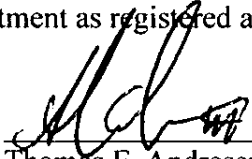
