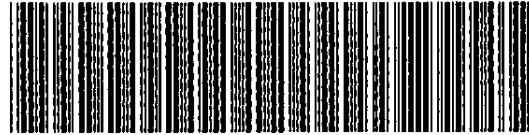

Dear Mrs., Miss or Ms. Fason,

Your letter dated 11 Jul 01 has been received with disappointment.

You state the name designated in your (my) document is unavailable since it is the same as, or it is not distinguishable from the name of an existing entity. I think that you are confused. If Merci Corporation, Inc. still legally exists in your records, then send me the form to change the corporate name from Merci Corporation, Inc. to Merci Corporation. The incorporator of Merci Corporation, Inc. was not very intelligent as Inc. is an abbreviation for Incorporation which means that the entity is/was a domestic profit making corporation. This in essence means the name of the corporation translates to Merci Corporation Corporation. So the Inc. behind the word corporation in the original listing is redundant, superfluous and inappropriate. I am not that ignorant nor legally untidy.

Next, the Corporate Detail Record Screen says "Last: ADMIN DISSOLUTION FOR ANNUAL REPORT FLD: 09/24/2010". That means the corporation was DISSOLVED for failure to file a franchise report and pay that filing fee. That means the name Merci Corporation is legally available for reassignment. Hence, my submission to you.

My filing will not ever be "abandoned" and will be pursued by all legal means until successfully completed.

Mildred L. Glinton was the President of Merci Corporation, Inc. The Resident Agent's address, I believe, was 2292 Southeast 4<sup>th</sup> Street, Boynton Beach, FL 33435 which is no longer correct.

The street address of Merci Corporation, Inc. was 3233 Lawrence Street, Detroit, MI 48206 and they did receive mail at P O Box 6821, Detroit, MI 48106 but not anymore. All of this old outdated information is of no legal consequence as your records show this old corporation and its name as "DISSOLVED".

So enclosed again is the filing wrongly returned to me. Please note that Mildred L. Glinton is listed this time properly as a Director, President and Treasurer. She no longer lives in Michigan but lives in Florida.

I have papers to dissolve Merci Corporation, a Michigan corporation, but will not do that until I receive the file number attesting the legal existence of the Florida corporation with this name.

Therefore, you are respectfully instructed to do your duty and to promptly file the incorporating papers for Merci Corporation as a Florida corporation. Your non-processing of these papers is slowing up progress.
