**ARTICLES OF INCORPORATION**  
**OF**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is **Bob Christian Electric, Inc.**

**ARTICLE II**

The existence of the corporation shall begin on July 25, 2011.

**ARTICLE III**

The street address and mailing address of the principal office of the Corporation is 1478 Song Street, Port Charlotte, Florida 33952.

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares.
