The undersigned Incorporator, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is ARCHON CONSULTING CORP. (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS
