## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF RANEYS, INC.

- 3. The amendment provided above does not affect an exchange, reclassification, or cancellation of any shares of Corporation stock issued prior to the filing of the Articles of Amendment.
