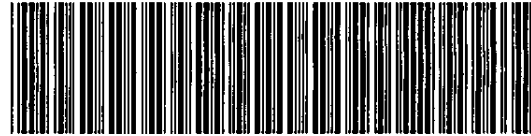





## ARTICLE I
