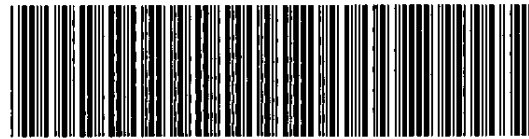

The name and address of the Incorporator of this corporation is Martin C. Boire, 595 West Granada Blvd, Suite J, Ormond Beach, FL 32174.

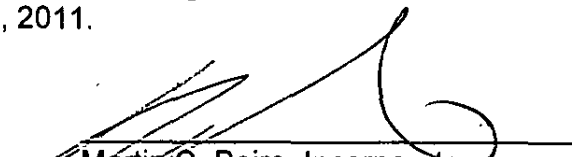
ARTICLE XI - INDEMNIFICATION

ARTICLE XII - AMENDMENT

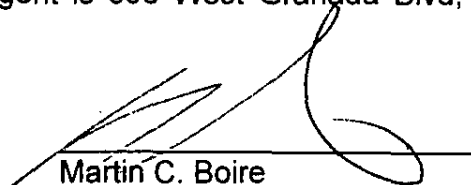
