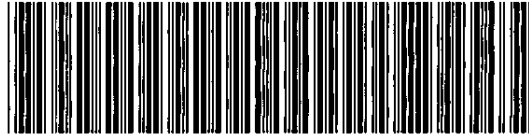

ARTICLES OF INCORPORATION
OF

The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation pursuant to the provisions of the Florida Business Corporation Act, Chapter 607, *Florida Statutes*.

ARTICLE I
