**ARTICLES OF INCORPORATION
OF
SARASOTA MOVING COMPANY, INC.**

In compliance with Chapter 607, Florida Statutes (Profit)

Article I Name

The name of the corporation shall be: SARASOTA MOVING COMPANY, INC.

Article II Principal Office

The principal street address and mailing address is:

4140 Bell Ave., Sarasota, Florida 34231

Article III Purpose

The purpose for which the corporation is organized is to engage in any lawful activity or act for which the corporation may be organized under the laws of the State of Florida.

Article IV Shares

The number of shares of stock is one-hundred-thousand (100,000). The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to natural persons authorized by law to hold stock in the professional corporation and in no event to anyone other than a natural person, estate, or trust as defined in 26 U.S.C. § 1361(c)(2) or its successor section. In addition, no stock shall be issued or transferred to a non-resident alien.

Article V Initial Officers and/or Directors

The names, addresses, and specific titles of the Board of Directors, who shall hold office until their successors are chosen, are:

1. Samuel Z. Nikolic, 4140 Bell Ave., Sarasota, Florida 34231; President and Director.

2. Ruth Nikolic, 4140 Bell Ave., Sarasota, Florida 34231; Secretary.

Article VI Registered Agent

Article VII Incorporator

Article VIII Duration

The corporation shall have a perpetual existence unless sooner dissolved according to law.

Article IX Number of Directors

The number of directors of this corporation shall be not less than one (1) and not more than nine (9).
