

# ARTICLES OF INCORPORATION OF SARASOTA MOVING COMPANY, INC.

In compliance with Chapter 607, Florida Statutes (Profit)

#### Article I Name

The name of the corporation shall be: SARASOTA MOVING COMPANY, INC.
