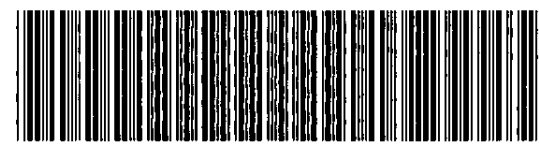

### **BY-LAWS**


