**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is Blackbirdbrown, Inc., and the principal address and principal place of business is 261 Ridge Road SW, Largo, Florida 33770.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 8240 118th Avenue North, Suite 300, in the City of Largo, County of Pinellas, Florida 33773. The name of its registered agent at such address is Steven W. Moore.

**ARTICLE III - PURPOSE**

#### **ARTICLE VI - AMENDMENTS**




