The undersigned, acting as incorporator of this corporation (the "Corporation"), pursuant to Chapters 607 and 621 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I - NAME OF CORPORATION**


The Corporation shall indemnify any officer or director, or any former officer or director of the Corporation, to the full extent permitted by law.


