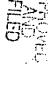

# ARTICLES OF INCORPORATION

OF

## STRONGVIEW HOLDINGS II CORP.

The undersigned, acting as incorporator, signs the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation shall be: STRONGVIEW HOLDINGS II CORP. (hereinafter the "Corporation").
