ARTICLES OF INCORPORATION of  
LOBBY FOR THE SILENT MAJORITY, Inc.  
a For Profit Corporation

The undersigned, as the Incorporator, with other persons desirous of forming a for profit corporation under the provisions of Chapter 607 Florida Statutes, do form a for profit corporation, and agree to the following Articles of Incorporation:

ARTICLE I

The name of this corporation is LOBBY FOR THE SILENT MAJORITY, Inc.

ARTICLE II

The street and mailing address of the principal office of this corporations shall be in care of Mark McCranie, 8349 Newgate Circle West, Jacksonville, FL 32244.

ARTICLE III

The general nature of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is to be organized and to operate a for profit information, technology, educational and charitable company to (1) perform research into all matters civic, cultural, economic, governmental, societal and political; and (2) to communicate the results of that research to citizens, private entities, public officials, and public entities; and (3) to do any and all lawful business.

The corporation shall have all of the general authority and powers conferred by the laws of the State of Florida, subject to these Articles of Incorporation, and subject to By-Laws to be adopted, to do all things necessary, convenient or desirable to accomplish the above purposes, and any one or more of them.

ARTICLE IV

The corporation shall authorize, issue and may have outstanding, ten million ( 10,000,000 ) shares of common stock. The Board of Directors may authorize and issue other classes and amounts of stock from time to time.

ARTICLES OF INCORPORATION of LOBBY FOR THE SILENT MAJORITY, Inc.

ARTICLE V

The name and address of the person who is to serve as the director for the ensuing year, or until the first meeting of the Board of Directors, is Mark McCranie, 8349 Newgate Circle West, Jacksonville, FL 32244.

ARTICLE VI

The initial officers of the corporation shall be a President and a Vice President, and such other officers as may be provided in the By-Laws. The name of the persons who are to serve as the initial officers of the corporation shall be President, Arthur W. Browning, Jr. and Vice President, James McCarthy.

ARTICLE VII

The name and address of the Registered Agent is Mark McCranie, 8349 Newgate Circle West, Jacksonville, FL 32244.

ARTICLE VIII

The name and address of the incorporator to these Articles of Incorporation is Mark McCranie, 8349 Newgate Circle West, Jacksonville, FL 32244.

ARTICLE IX

The corporation shall be authorized and empowered to pay compensation for value obtained, or for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III. Such compensations, payments and distributions shall be made at the sole discretion of the Board of Directors.

Upon the liquidation or dissolution of this corporation, the assets of this corporation then remaining after provision for liabilities, shall be distributed at the sole discretion of the Board of Directors.

ARTICLES OF INCORPORATION of LOBBY FOR THE SILENT MAJORITY, Inc.

ARTICLE X

The corporation is to exist perpetually, and is to have a fiscal year from January 1 to December 31.

ARTICLE XI

The business of this corporation shall be managed by the Board of Directors. This corporation shall have one director initially. The number of directors may be increased from time to time by the By-Laws, but shall never be more than seven. The Board of Directors shall be elected and hold office in accordance with the By-Laws.

ARTICLE XII

The conduct of the business and the affairs of this corporation shall be governed by these Articles of Incorporation and the By-Laws to be adopted. The By-Laws of this corporation shall be such as the Board of Directors of this corporation shall adopt from time to time.

ARTICLE XIII

These Articles of Incorporation and the By-Laws may be amended at any regular meeting of the Board of Directors, a quorum being present, by a two-thirds ( 2/3 ) vote of the members present.
