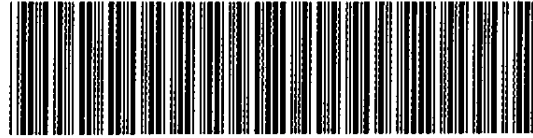

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of this corporation is Nadia Market, Inc.
2. TERM. This corporation shall exist perpetually.

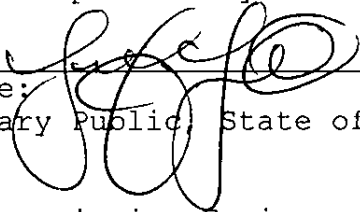

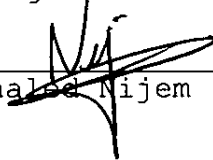
