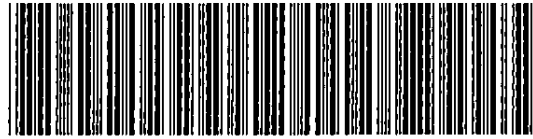


- a. The name of the converted business entity immediately prior to the filing of this Certificate of Conversion was Pristine Property Landscape and Maintenance, LLC.


