# ARTICLES OF INCORPORATION OF: MCAULIFFE IMPORT AND EXPORT, CORP

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

## ARTICLE I - NAME

#### ARTICLE VII AMENDMENT
