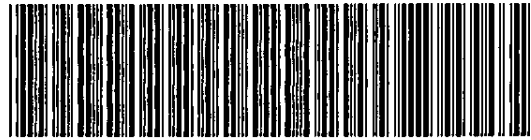

a natural person competent to contract, hereby forms a Domestic  
Corporation under the laws of the State of Florida pursuant to the provisions  
of Section 607.164 Florida Statutes

## **ARTICLE I: NAME**
