**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
NEIGHBORHOOD REUNIONS, INC.**

Pursuant to the provisions of Chapter 607, *Florida Statutes*, the undersigned corporation adopts the following amendment to its Articles of Incorporation, as originally filed with the Secretary of State of the State of Florida on September 26, 2011.

- I. The name of this corporation is Neighborhood Reunions, Inc.
- II. Article IV of the Articles of Incorporation is deleted in its entirety and replaced with the following:

"ARTICLE IV

The corporation is authorized to issue ten million (10,000,000) shares of common stock, par value \$0.001."

- III. These Articles of Amendment were adopted on the 22 day of August, 2012.
- IV. The number of votes cast for this amendment by the shareholder was sufficient for approval.
