In compliance with the requirements of Chapter 607 and/or Chapter 621, F.S. (Profit), the undersigned being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ST. CLOUD BOAT RENTAL, INC.




