ARTICLES OF INCORPORATION OF M & B Cleaning of St. Augustine, Inc

The undersigned, for the purpose of forming a Corporation under Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND PLACE OF BUSINESS

The name of this Corporation is M & B Cleaning of St. Augustine, Inc. with its principal place of business at 1660 CR 13A North, Saint Augustine, FL 32092.

DURATION
