

SKELLY, JR.'s, whose address is 3898 West Whitewater Avenue, Weston, FL 33332, Motion for Default Final Judgment (the "Motion") against Defendant, PELION, INC., whose address is 5301 North Federal Highway, Suite 130, Boca Raton, FL 33487, and this Court having reviewed and considered the Motion and the Affidavits attached thereto, no one having appeared on behalf of Defendant Pelion, Inc., having heard argument of Plaintiff's counsel, having reviewed the Court file and finding that this Court on July 20, 2015 entered an Order Striking Pelion, Inc.'s Answer, Affirmative Defenses and Counterclaims and a Default against Pelion, Inc. in this action, and this Court being otherwise fully advised in the premises, it is hereby

#### ORDERED AND ADJUDGED:

- 1. Plaintiff, RICHARD D. SKELLY, JR.'s, Motion for Default Final Judgment against Defendant Pelion, Inc. is hereby granted.
- 2. Plaintiff, RICHARD D. SKELLY, JR. shall recover from Defendant, PELION, INC. damages in the sum of \$246,875.00, together with interest calculated at the statutory rate of 4.75 percent in the amount of \$10,955.50, costs in the amount of \$504.00, and attorneys fees in the

amount of \$24,810.50, for a total Final Default Judgment against Pelion, Inc. in the amount of \$283,141.89, which shall bear interest at the rate of interest currently in effect as provided by Florida Statute \$55.03, for which Final Default Judgment amount of \$283,141.89, let execution immediately issue.

- 3. Defendant, Pelion, Inc. shall complete under oath Form 1.977, Florida Rules of Civil Procedure, including all required attachments, and serve them on Plaintiff's attorney at the offices of Fischler & Friedman, P.A., located at 1000 South Andrews Avenue, Fort Lauderdale, Florida 33316, within 45 days from the date of this Default Final Judgment, unless the Default Final Judgment is satisfied or post-judgment discovery is stayed. Copies of the required Forms are being provided to the Defendant, Pelion, Inc. contemporaneously herewith. The Defendant, Pelion, Inc. Shall file with the Clerk of the Court a Notice of Compliance with this Order and shall serve a copy of the Notice of Compliance on the Plaintiff's attorney.
- 4. Jurisdiction of this case is retained to enter such further orders as may be proper to compel Defendant, Pelion, Inc. to complete Form 1.977, Florida Rules of Civil Procedure, and serve it on the Plaintiff's attorney.
