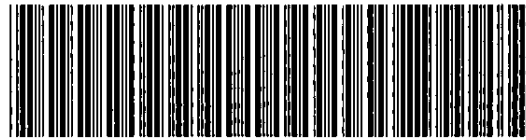

**ARTICLES OF INCORPORATION
OF
Chokshi Equipment Corporation**

The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I - Name

The name of the corporation is: **Chokshi Equipment Corporation**

ARTICLE II - Principal Office and Mailing Address

ARTICLE III - Shares
