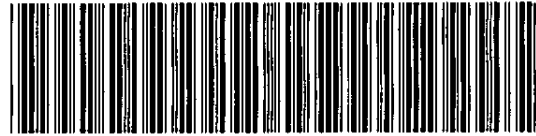

The undersigned Incorporator, for the purpose of forming a corporation in accordance with Chapter 607 of the Florida Statutes, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address
