ARTICLES OF INCORPORATION OF SMITH TRANSPORTATION SERVICES, INC.

The undersigned, setting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation.

ARTICLE I - CORPORATE NAME

The name of the Corporation shall be:
