**ARTICLES OF INCORPORATION
(Professional Corporation)
OF
BOUGIE CENTER FOR CHIROPRACTIC AND ALTERNATIVE MEDICINE, P.A.**

The undersigned, who is duly licensed to act as a chiropractor in the State of Florida desires to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopt, the following Articles of Incorporation:

I. NAME

The name of the Professional Corporation is Bougie Center for Chiropractic and Alternative Medicine, P.A.

II. PURPOSE

The purpose for which the Corporation is organized is to engage in the activities of chiropractic medicine and matters related thereto.

**III. ELECTION UNDER PROFESSIONAL
CORPORATION ACT**

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

IV. DURATION

The term of existence of the Corporation is perpetual.

V. CAPITAL STOCK

The number of shares the Corporation is authorized to issue is 1,000, all of which shall be common shares with a par value of \$1.00 per share.

VI. STATED CAPITAL

The amount of capital with which the Corporation shall begin business is \$100.00.


