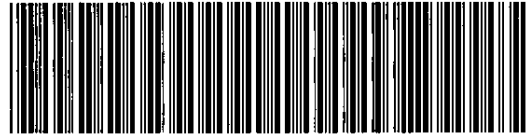

Name

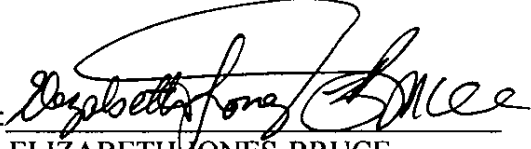
