

The number of shares the corporation is authorized to issue is 10,000."


2. The foregoing amendment was adopted by the unanimous written consent of the Shareholders dated July 31, 2014.

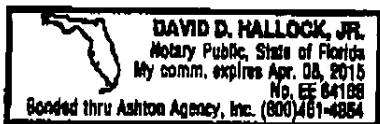
