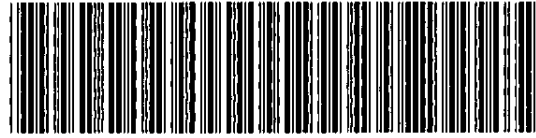

NAME

EFFECTIVE DATE 9/22/11

The name of this corporation is Vasili Transportation, Inc.

ARTICLE II.
