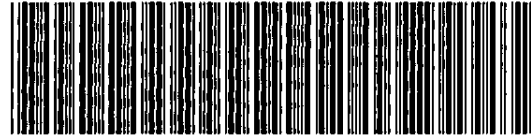


This Corporation shall have all the corporate powers enumerated in the Florida Business Corporations Act.


