# Articles of Incorporation Of Venenvios International Cargo Inc

The Undersigned, acting as Incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of corporations for profit, file and adopt the following Articles of Incorporation:

# Article I

The name and address of the corporation:

The duration period of the corporation is perpetual.

#### Article III

The date and time of the commencement of the corporate existence shall be the date of the filing of these Articles of Incorporation by the Department of State.

Section 1: The purpose(s) for which the corporation is organized is to engage in and carry on the transaction(s) of any or all-lawful business(es) for which the corporation may be incorporated under the Florida General Corporation Act in the State of Florida, or in any other State in the United States of America or in any foreign country.
