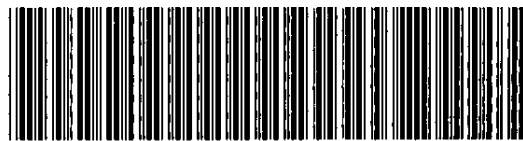

ARTICLE I. NAME

The name of this corporation is SUMTER LAWN & PEST, INC.

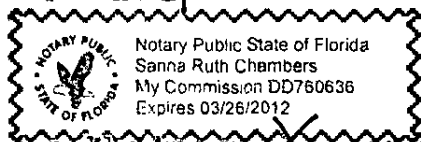

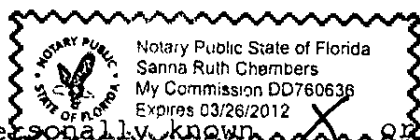
