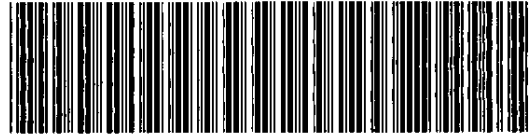

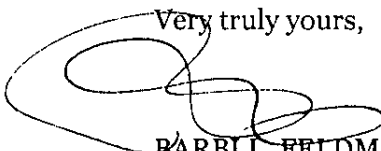

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE 9-28-11

The corporation shall have at least one Board member but need not have any more than one. Garret Miles shall at all times be the a member of the Board and is hereby designated as CEO and President of the company.

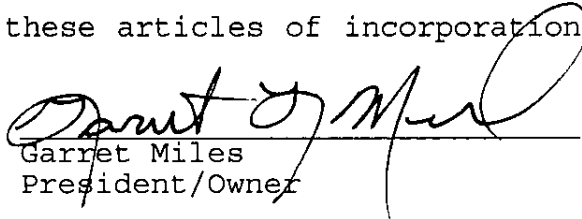

ARTICLE X

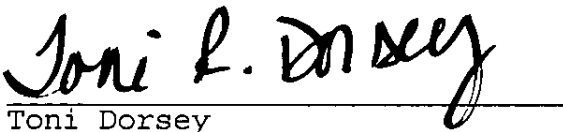
The owner of the corporation is Garret Miles and he will be the only officer and President of the corporation, unless he elects to sell or others appoint someone in his stead.

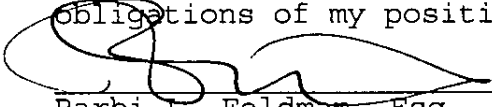
