**ARTICLES OF INCORPORATION
OF**

STRUCTURAL COMPOSITES HOLDING COMPANY

The undersigned, acting as incorporator of Structural Composites Holding Company under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

ARTICLE II. ADDRESS

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon filing these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock, with a par value of \$0.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 4255 Dow Rd., Melbourne, Florida 32934, and the name of the corporation's initial registered agent at that address Scott M. Lewit.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

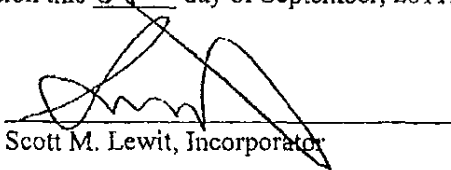

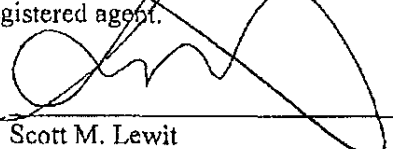
Pursuant to Sections 48.091 and 607.0501, Florida Statutes, the following is submitted:
