**ARTICLES OF INCORPORATION  
OF  
MSD PANELS, INC.**

**ARTICLE I**

The name of the corporation is **MSD PANELS, INC.** (hereinafter the "Corporation").

**ARTICLE II**

The address of the principal office and mailing address of the Corporation is c/o Burton A. Landy, One S.E. Third Avenue, 25<sup>th</sup> Floor, Miami, FL 33131.

**ARTICLE III**

The purpose for which the Corporation is organized is to transact any lawful business in general.

**ARTICLE IV**

This Corporation shall have the authority to issue One Thousand (1,000) shares of Common Stock having a par value of \$1.00 per share. Each issued and outstanding shares of common stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.


ARTICLE VII
