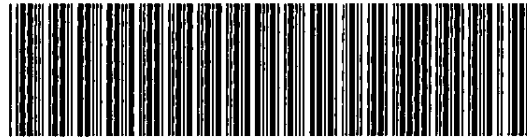

ARTICLES OF INCORPORATION
TJ'S AUTO SERVICE & DETAILING, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is TJ'S AUTO SERVICE & DETAILING, INC.

ARTICLE II - PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 10 N Main Street, City of Chiefland, Florida, 32626. The name of the initial registered agent of the corporation, located at that office, is Thomas J. McKechnie.

ARTICLE III - EFFECTIVE DATE/DURATION

The existence of the corporation shall begin October 1, 2011 and shall have perpetual existence, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue only 100 shares of one class of stock, and all issued stock shall be held of record by not more than 35 shareholders. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in IRC §1361(c)(2) (or its successor section). In addition, no stock shall be issued or transferred to a nonresident alien.

ARTICLE V - CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on corporations by the laws of the State of Florida.

ARTICLE VI - BYLAWS

The initial shareholders shall adopt bylaws at a meeting to be held for that purpose not more than thirty days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by such as the by the affirmative vote of three fourths of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.
