



4. I hereby certify that I have no intention of revoking the dissolution of Premier, therefore, releasing the name for use to another entity.

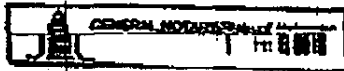


