

ARTICLES OF INCORPORATION

STERILE SMART, INC.

The undersigned incorporator of this corporation, pursuant to Chapter 607, Florida Statutes, as amended, adopt the following Articles of Incorporation:

ARTICLE I

The name and address of the corporation is <u>Sterile Smart, Inc. 1516</u> <u>Lantana Dr., Weston, FL 33326</u>

ARTICLE II

The purpose of this Corporation will be to carry on any business or enterprise which may be exercised by a corporation, organized pursuant to the Florida General Corporation Act.

The corporation has been organized for the purposes of transacting any or all lawful business, and may do any and all things herein mentioned as fully as and to the same extent as a natural person might or could do.

- (a) To engage in all aspects of business allowed by law concerning real and personal property;
- (b) To purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of and to invest, trade, deal in, and deal with goods, wares, merchandise, or other personal property of every class and description whatsoever;
- (c) To buy, sell, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purpose of any of the said businesses, or commonly supplied or dealt in by persons engaged in any such business, or which may seem capable of being profitably dealt with in connection with any of the said businesses; to carry on any lawful

business necessary or incidental to the accomplishment of the purpose or objects of the corporation, whether or not such business in similar in nature to the purposes and objects set forth in these Articles.

- (d) To borrow money and contract debts when necessary in the purchase or acquisition of real, personal and intangible property, business rights or franchises, or for additional working capital, or for any other object in or about its business affairs and without limit as to amount; to incur debt and to raise, borrow and secure the payment of money in any lawful manner, including the issuance and sale or other disposition of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidences of indebtedness of all kinds, whether secured by mortgage, pledge, deed of trust or otherwise.
- (e) To purchase or otherwise acquire, become interested in, deal in and with, invest in, hold, pledge, sell, mortgage, lend money on, exchange or otherwise dispose of, or realized upon as owner, agent, broker, or factor, all forms of securities, including stocks, bonds, debentures, mortgages, notes, evidences of indebtedness, leases, options, certificates of interest, participation certificates, voting trust certificates evidencing shares of or interests in common law trusts, trusts and trust estates or associations, certificates of trust or beneficial interest in trusts, mortgages, contracts and other instruments, securities and rights; to investigate and report with respect to, and to undertake, carry on, aid, assist or participate in the liquidation or reorganization of financial, commercial, mercantile, manufacturing, industrial or other business concerns, firms, associations and corporations; to institute, participate in or promote commercial, mercantile, financial and industrial enterprises and operations.
- (f) To do any and all things necessary and proper for the accomplishment of the objects enumerated in these Articles of Incorporation or any amendment thereto necessary and

incidental to the protection and benefit of the corporation and in general to carry on any lawful business necessary or incidental to the attainment of the objects of the corporation, whether or not such business is similar in nature to the objects set forth herein, it being understood, that the enumeration of specific powers in these Articles of Incorporation will not be deemed to be exclusive, but all other lawful powers conferred by the statutes of the State of Florida are hereby included.

<u>ARTICLE III</u>

This corporation will have perpetual existence unless earlier dissolved pursuant to law.

ARTICLE IV

This corporation is authorized to issue Five Hundred (500) Shares at One DOLLAR (\$1.00) Par Value Common Stock, which will be designated "Common Shares". The Board of Directors may authorize the issuance of such stock to such persons upon such terms and for such consideration as they may deem appropriate. The consideration may include money or other property, which property shall be received at just valuation to be fixed by the Board of Directors of this corporation. All of such stock, when issued, shall be fully paid for, and exempt from assessment.

<u>ARTICLE V</u>

Each shareholder of any class of stock in this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury share of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire shares of any unissued or treasury shares.

ARTICLE VI

The amount of capital with which this corporation will begin business shall not be less than Five Hundred DOLLARS (\$500.00).

ARTICLE VII

The name and street address of the first Director of this Corporation who shall hold office for the first year or until his successors are chosen shall be:

ARTICLE VIII

The initial Board of Directors shall consist of One (1) member(s). The number of directors may be increased or decreased from time to time by a vote of stockholders, but in no case shall the number of Directors be less than One (1).

ARTICLE IX

The street address of the initial **registered office** of this corporation is: <u>1516 Lantana Dr.</u>, <u>Weston, FL 33326</u> and the name of the initial **registered agent** of this corporation is:

The Board of Directors from time to time may move the registered office to any other address in the State of Florida.

ARTICLE XI

In the absence of fraud, no contract, or other transaction between this corporation and any other person, corporation, firm, association or partnership shall be affected or invalidated by the fact that any director or officer of this corporation is pecuniarily or otherwise interested in, or is a director, member or officer of any such other corporation, firm, association or partnership or is a party to or is pecuniarily or otherwise interested in such contract or other transaction, or in any way connected with any person, firm, association, partnership, or corporation pecuniarily or otherwise interested therein. Any director may be counted in determining the existence of a quorum, at any meeting of the Board of Directors of this corporation, for the purpose of authorizing any such contract, or transaction with like force and affect, as if he were not so interested, or were not a director, member or officer of any such other corporation, firm, association or partnership.

ARTICLE XII

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding common shares.

The original incorporators of this Corporation shall have the right, upon its organization, to assign and deliver their subscription of stock to any other person, or to firms or corporations who may hereafter become subscribers to the capital stock of the corporation, who upon acceptance of said assignment, shall stand in lieu of the original incorporators, and assume and carry out all the rights, liabilities and duties entailed by said subscribers, subject to the laws of the State of Florida, and the execution of the necessary instruments of assignment.

ARTICLE XIII

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

ARTICLE XIV

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
