The undersigned incorporator, being duly authorized to execute and file these Articles of Incorporation, for the purpose of forming a professional services corporation pursuant to Title XXXVI, Chapters 607 and 621 of the Florida Statutes, hereby certifies that:

ARTICLE I
NAME

The name of the professional service corporation (hereinafter referred to as the "Corporation") is:

Corporation may also engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation, incidental to such professional services.

ARTICLE V AUTHORIZED SHARES

The aggregate number of shares which the Corporation shall have the authority to issue is ONE THOUSAND (1,000) shares, all of which shares shall be common stock with a par value of \$.01 per share.

ARTICLE VI REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of the Corporation is located at One Tampa City Center, 201 North Franklin Street, Suite 3200, Tampa, Florida 33602, and the initial registered agent of the Corporation at such office is Lina Angelici, Esq. The Corporation shall have the right to change such registered office and such registered agent from time to time, as provided by law.


