ARTICLES OF INCORPORATION OF THE LAW OFFICE OF SCOTT C. KING, P.A.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE I NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is The Law Office of Scott C. King, P.A.

Section 1.2. Street Address of Principal Office. The street address of the principal office of the corporation is 653 SE Central Parkway, Stuart, FL 34994.

ARTICLE II DURATION

Section 2.1. Duration. This corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed, except that if they are not filed by the Department of State of Florida within five business days after they are executed, corporate existence shall commence upon filing by the Department of State.

ARTICLE III PURPOSES

Section 3.1. Purposes. This corporation is organized for the purposes of transacting legal services and any or all lawful business related to providing legal services permitted under the laws of the United States and of the State of Florida.

ARTICLE IV CAPITAL

Section 4.1. Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000,000 shares of voting common stock having a par value of \$0.01 per share.

ARTICLE V INITIAL REGISTERED OFFICE AND AGENT
