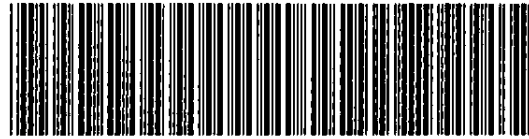

Signed by the undersigned for the purpose of forming a corporation under the Florida Business Corporation Act.

FIRST: The name of the corporation is SOUTH FLORIDA JOINT & SPINE, INC.

SECOND: The corporation will be effective October 10, 2011.

THIRD: The purposes for which this corporation is organized are to engage in any activity within the purposes for which corporations may be organized under the Florida Business Corporation Act.

FOURTH: The address of the corporation's initial registered office and the name of the corporation's initial registered agent at such address are Richard B. Petigrow, Esq., 9900 West Sample Road, Suite 300, Coral Springs, Florida 33065.

If the Florida Business Corporation Act is hereafter amended to authorize the further elimination or limitation of the liability of directors and officers then the liability of a director or officer of the Corporation, in addition to the limitation on personal liability provided herein, shall be eliminated or limited to the fullest extent permitted by the Florida Business Corporation Act, as so amended.
